

TinyLogic UHS Dual 2-Input NOR Gate

Description

The NC7WZ02 is a dual 2-Input NOR Gate from onsemi's Ultra High Speed Series of TinyLogic. The device is fabricated with advanced CMOS technology to achieve ultra high speed with high output drive while maintaining low static power dissipation over a very broad V_{CC} operating range. The device is specified to operate over the 1.65 V to 5.5 V V_{CC} range. The inputs and output are high impedance when V_{CC} is 0 V. Inputs tolerate voltages up to 6.5 V independent of V_{CC} operating voltage.

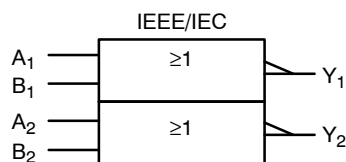
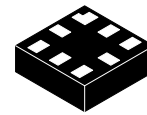
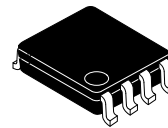


Figure 1. Logic Symbol

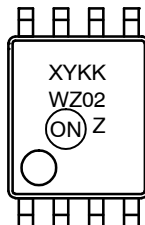

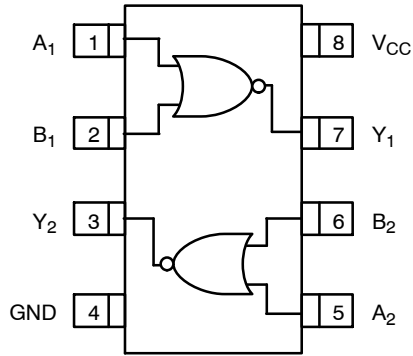


Figure 2. Pin Assignment for US8 (Top View)

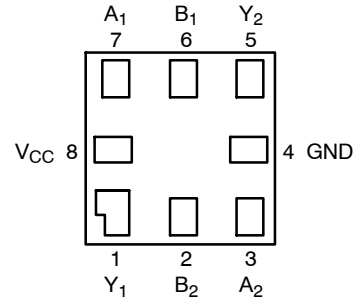
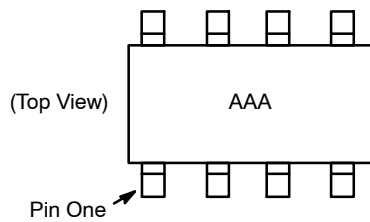


Figure 4. Pad Assignments for MicroPak (Top Through View)

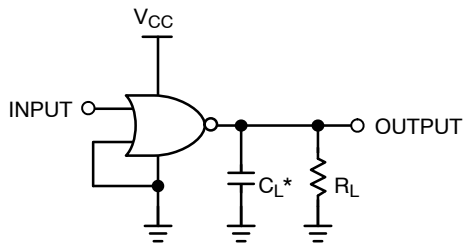

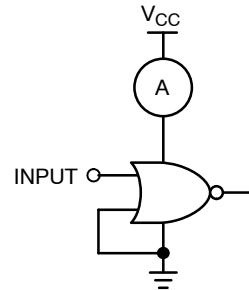
2. C_{PD} is defined as the value of the internal equivalent capacitance which is derived from dynamic operating current consumption (I_{CCD}) at no output loading and operating at 50% duty cycle. (see Figure 6) C_{PD} is related to I_{CCD} dynamic operating current by the expression: C_{PD} = I_{CCD} / (V_{CC}) (F).

Figure 6. I_{CCD} Test Circuit

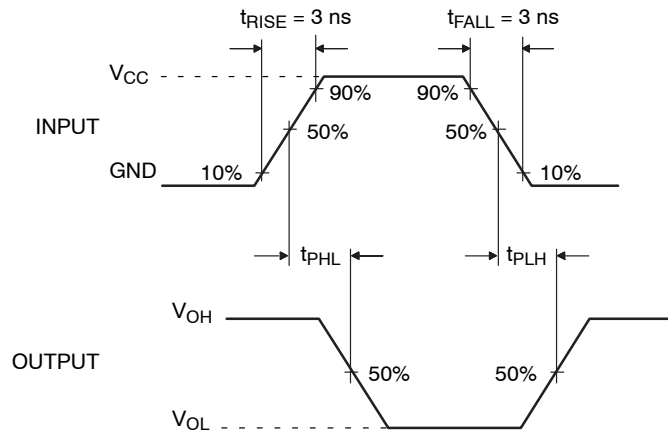


Figure 7. AC Waveforms

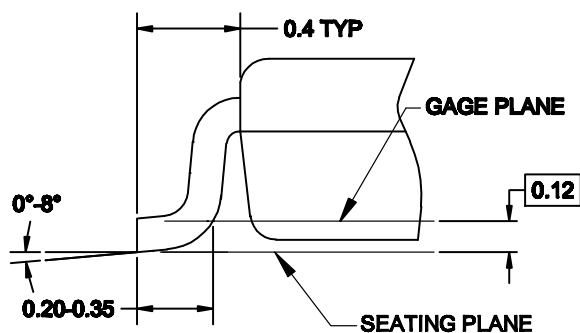

RECOMMENDED LAND PATTERN



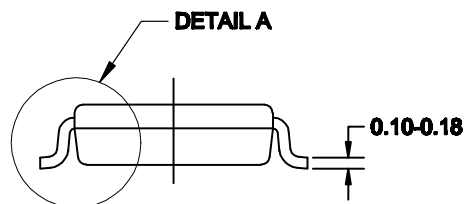
